Following functions shall be performed by each Town Vending Committee (TVC) as per provision of the "The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014"

The Meetings of TVCs & Functions :-

As provided under Section 23(1) & (2) of the Act, The Town Vending Committee shall meet once in a quarter duly following 51% quorum and 7 clear days notice period. Following functions shall be performed by TVCs as per provisions of the Act viz.

- a) Registration of street vendors through photo census, registration, new entrants, ID cards registration fee and process.
- b) Collection of revenue-registration fee, monthly maintenance charges, fines and others
- c) Recommending to the ULB for demarcation of vending zones
- d) Eviction, relocation and confiscation
- e) Promotional measures (Public health and hygiene, Education and skill training, Credit and insurance, social security, allotment of space, stationery stalls, rehabilitation of child vendors etc.)
- f) Maintenance of records
- g) Facilitation of provision of basic amenities
- h) Promotion of self regulatory activity
- i) Promotion of membership based on associations and federations of street vendors
- j) Monitoring and review of street vending activities
- k) Resolution of disputes among street vendors and between Street Vendors and others
- 1) The TVC shall recommend the local authority for preparation of plan for street vending as provided under Sec 21(1) & (2) of the Act.

Besides the above, TVC shall conduct a survey within the respective areas to study the need of the vendors and consumers. TVC shall also prepare schemes based on the survey and forward its recommendation to the Government through Corporation for approval.
