GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR GENERAL ADMINISTRATION DEPARTMENT

NOTIFICATION

- **e File No. 255166.-** The Governor of Assam is pleased to make provision for providing Government job for Next of Kin (NOK) of Martyr soldier (Killed in Action) (Army/Navy/Air Force) in relaxation of provision of direct recruitment prescribed in Rules prevailing in the State in respect of posts of B, C and D category on the following terms and conditions:
- 1. This provision of employment in Government job for Next of Kin (NOK) of Martyr soldier (Killed in Action) (Army/Navy/Air Force) shall be applicable in respect to bonafide resident of Assam only.
- 2. The NOK(s) are to be considered for posts of B, C and D category as the case may be, keeping in view their educational qualifications, eligibility criteria and provisions as laid down in the recruitment rules for the concerned post.
- 3. The consideration shall be admissible even if one or more members of the family of Martyr soldier (Killed in Action) is! are in Government service.
- 4. The relaxation with regard to age and time limit shall be made with the prior approval of Hon'ble Chief Minister of Assam.
- 5. The request for grant of employment assistance shall be made by the Next of Kin (NOK) of Martyrs soldiers (Killed in Action) to the concerned District Commissioner within a period of one year of death. In case where Next of Kin (NOK) is a minor he/she will also be eligible to get the benefit as soon as he/she attains majority according to his/her qualifications.

- 6. The request for recruitment by Next of Kin (NOK) of Martyr's (Killed in Action) shall be forwarded by concerned District Commissioners to Directorate of Sainik Welfare for consideration and appropriate action. Directorate of Sainik Welfare shall compile such proposals and forward to General Administration Department forgetting approval/concurrence of Finance Department and Personnel(A) Department.
 - 7. The Consideration shall be made only against direct recruitment quota post.
- 8. The employment assistance shall be given in relaxation of recruitment procedure only after due approval of Finance Department and Personnel (A) Department.

The appointment under these instructions shall be made in the Government Department/Board/Corporation and Autonomous Bodies where posts are lying vacant.

The concerned District Commissioner shall ascertain the vacancy position, scrutinize/verify the papers of the applicants relating to age, educational qualification, fact of being dependent of the Defence Personnel killed in various operations/counter insurgency. operations, death of such personnel, status of bonafide resident of Assam and submit the same to the concerned appointing authority under intimation to Directorate of Sainik Welfare.

Concerned District Commissioners will also co-ordinate with the appointing authority before recommending the cases so as to ensure availability of posts and subsequent appointment without delay.

These instructions may be brought to the notice of all concerned for strict compliance.
