| Short title, extent and commencement | <p>1. (1) This Act may be called the Madhabdev University (Amendment), 2023.</p> <p>(2) It shall have the like extent as the principal Act.</p> <p>(3) It shall come into force at once.</p>  |   |
| Amendment of section 6               | <p>2. In the principal Act, in section 6, in clause (viii), in the first and second line, for the words “colleges and halls”, the words colleges, halls and hostels shall be substituted.</p>   |   |
| Amendment of section 20              | <p>3. In the principal Act, in section 20, in sub-section (6), for the words “Examiner, Local Accounts”, the words “Comptroller and Auditor General of India” shall be substituted.</p>   |   |
| Amendment of section 45              | <p>4. In the principal Act, in section 45, in sub-section (1), in the fourth line, for the words “a firm of Chartered Accountants subject to overall Audit Scrutiny by the Accountant General, Assam”, the words “Comptroller and Auditor General of India” shall be substituted.</p> |   |
