GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR HEALTH & FAMILY WELFARE (B) DEPARTMENT

NOTIFICATION

The 17th November, 2021

No.HLB.415/2017/175.-The Governor of Assam is hereby pleased to make the following rules to regulate the admission of students into the Post Graduate Degree Course in Government Ayurvedic College, Guwahati, namely:-

1. SHORT TITLE, COMMENCEMENT AND APPLICATION:

- (1) These rules may be called the Assam Ayurvedic College (Regulation of Admission to Post-Graduate Course) Rules, 2021.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. DEFINITION:

In these rules unless the context otherwise requires-

- (a) "AIAPGET" means All India AYUSH Post Graduate Entrance Test conducted by any other competent authority as may be decided by the Ministry of AYUSH, Government of India from time to time for admission to the Post Graduate Courses for all AYUSH Colleges;
- (b) "AIQ" means the seats reserved for the students selected by the Central Government under 15% All India Quota;

- (c) "AYUSH" means Ayurveda, Yoga & Naturopathy, Unani, Siddha, and Homoeopathy;
- (d) "BAMS" means Bachelor of Ayurvedic Medicine and Surgery;
- (e) "Board" means a Selection Board constituted under rule 8(1);
- (f) "CCIM" means Central Council of Indian Medicine;
- (g) "Central Government Nominee" means nomination of candidates by Ministry of AYUSH, Government of India from deficient State/UTs for Post Graduation course against the seats earmarked by the donor Institute/College for the candidates of Central Government Nomination;
- (h) "CGN" means Central Government Nominee;
- (i) "College"means the Government Ayurvedic College, Guwahati, Assam;
- (j) "Council" means the Central Council of Indian Medicine;
- (k) "Deficient State/UT" means the State/UT in which there is no Post Graduation course in the specialty/specialties in the Government run Institute.
- (I) "Director of AYUSH" means Director of AYUSH, Assam.
- (m) "Donor Institutes" means in which institutes seats under 'Central Pool' are reserved for Central Government Nomination of candidates.
- (n) "EWS" means Economically Weaker Section;
- (o) "GOI" means the Government of India;
- (p) "Government" means the Government of Assam;
- (q) "Government Ayurvedic College" means the Government Ayurvedic College, Guwahati, Assam;
- (r) "IMCC" means Indian Medicine Central Council;
- (s) "MOBC" means More Other Backward Classes;
- (t) "NEC" means North Eastern Council;
- (u) "OBC" means Other Backward Classes;
- (v) "Post-Graduate Course" means Post-Graduate Degree Course in Ayurveda of Government Ayurvedic College as approved by the Central Council of Indian Medicine;

- (w) "Post-Graduate Degree" means Post-Graduate Degree in Ayurveda;
- (x) "Private CGN Candidates" means aspirants/interested candidates who are not in service of any Government run medical institute of the deficient state/UT and nominated by such deficient state/UT as CGN for admission under 'central pool' reserved seats in the donors Institutes.
- (y) "PwD" means Persons with Disabilities.
- (z) "SC" means Scheduled Caste;
- (za) "Sponsored Candidates" means nominated candidates as CGN, who are employee of any deficient state/UT Government, run medical institutions, for Central Government Nomination whose emoluments would be borne during study period of the course by the concerned sponsoring deficient State/UT Government and not by donor Institute.
- (zb) "State Quota Seats" means the seats available for admission into 1st year Post Graduate Degree Course in the Government Ayurvedic College, Guwahati, only for the State Quota candidates;
- (zc) "State Quota Candidates" means those candidates of State of Assam who appeared and secured qualifying marks in the AIAPGET of that year and applying for the State Quota Seats;
- (zd) "ST(H)" means Scheduled Tribes(Hills);
- (ze). "ST(P)" means Scheduled Tribes(Plains);

3. NUMBER OF SEATS:

The total number of seats available in Government Ayurvedic College at the time of commencement of these rules and their distribution is shown in **Schedule-I** of these rules. Any changes in number of seats shall be notified by the office of the Director of AYUSH, Assam in due course of time.

- 4. RESERVATION OF SEATS/QUOTA AND PROCEDURE OF SELECTION OF CANDIDATES AGAINST THE RESERVED SEATS/QUOTA (REFERRED IN DETAIL AT SCHDULE-II):
 - (i) All India Quota Seats- 15% of the total seats as referred to in rule 3 of these rules shall be reserved for the candidates of All India Candidates. The Ministry of AYUSH, Government of India shall select them through counseling on the basis of merit of AIAPGET in each academic session and recommend for admission against the All India Quota Seats. Any seat remaining vacant against 15% of All India Quota and surrendered/reverted back by Ministry of AYUSH, Government of India shall be filled up by the eligible candidate from the open category of State Quota candidates in order of merit of AIAPGET through counseling process.

- (ii) N.E.C. Quota Seats- Two seats (i.e. one inAyurved Samhita & Siddhanta and another one in Kayachikitsa) shall be reserved for the Candidates of North Eastern States except Assam in each academic session. The candidates shall have to qualify the AIAPGET of that year. The selection shall be made through counseling amongst them in order of merit of AIAPGET. The Secretary, North Eastern Council (N.E.C.) shall recommend the candidates through a certificate at Annexure-I in Application Form at Schedule-III of these rules and it must be submitted along with the duly filled up Application Form to be eligible for the N.E.C. Quota Seat. In absence of eligible candidate under NEC quota, the vacant seats/seat will be filled up by the eligible candidate from the open category of State Quota candidates according to the merit of AIAPGET through counseling process.
- (iii) CGN Quota Seats- Two seats (i.e. one inAyurved Samhita & Siddhanta and another one in Kayachikitsa) shall be reserved for the candidates of Central Government Nomination and the seats shall be filled up as per recommendation of Ministry of AYUSH, Government of India. If no sponsored candidate from any deficient State Government/UTs is available for nomination by the Ministry of AYUSH, Government of India, the vacant seats/seat will be filled up by Private CGN candidate recommended/nominated by deficient State Government/UTs. However, the Private CGN candidates shall have to obtain qualifying mark of the AIAPGET and their selection will be made in order of merit of AIAPGET through counseling as per the guideline of Ministry of AYUSH, Government of India.

In case, no Central Government Nominee (sponsored or private candidate), the vacant seats/seat against the CGN quota will be filled up by eligible candidate from the open category of State Quota candidates according to merit of AIAPGET through counseling process.

(iv) State Quota Seats- After allocation of Post Graduation Seats for All India Quota, CGN Quota and NEC Quota, the remaining seats will be considered as State Quota Seats and the seats will be filled up by selection of candidates through counseling process as per rules as mentioned hereinafter.

5. RESERVATION OF STATE QUOTA SEATS (REFERRED IN DETAIL AT SCHEDULE-II):

(i) EWS-

10% of the total State Quota Seats.

To be eligible for EWS quota seats, the candidates must submit a certificate from concerned Circle Office or Circle Officer as per Office Memorandum No. ABP.07/2019/4 dated 10th April 2019 and ABP.07/2019//16

dated 31/12/2019 issued by Personnel Department, Government of Assam or any rule for the purpose as applicable from time to time along with the duly filled up Application Form at Schedule-III of these rules.

(ii) SC 7% of the total State Quota Seats.

(iii) ST(P) 10% of the total State Quota Seats.

(iv) **ST(H)** 5% of the total State Quota Seats.

(v) **OBC/MOBC** 15% of the total State Quota Seats.

5% seats shall be reserved for Divyanga (PwD) candidates. Provided that these 5% reservation for Divyanga (PwD) Category is not a separate reservation over and above other reservation. If the disabled candidate belongs to reserved categories such as SC /ST /OBC /MOBC /EWS or General category, he/she shall be adjusted against the category to which he/she belongs.

While selecting the Divyanga (PwD) candidates, the Selection Board shall follow the Norms as mentioned in the CCIM Notification vide no. 4-90/2018-PG Regulation (Ayurved) dated 24-07-2019 or as notified by Ministry of AYUSH, Government of India/CCIM from time to time as applicable.

(vii) Medical Officer 2(two) seats. (Ayurvedic)

(vi)

Divyanga (PwD)

These 2 seats shall be distributed in 6 (six) different Post Graduation Specialties on rotation basis in every academic session as shown at **Schedule-IV** of these rules.

(viii) In absence of eligible candidate under reserved category against the respective reserved seats/quota, the vacant seats shall be filled up by eligible candidate from the open category of State Quota candidates according to merit of AIAPGET through counseling process.

6. ELIGIBILITY CRITERIA FOR ADMISSION INTO POST GRADUATE COURSE IN GOVERNMENT AYURVEDIC COLLEGE, GUWAHATI:

- (i) Any candidate who desire for admission into Post Graduation Course-
 - (a) must possess the degree of Ayurvedacharya (Bachelor of Ayurveda Medicine and Surgery) from a recognised University or Board or medical institution specified in the Second Schedule of Indian Medicine Central Council Act 1970 and enrolled in Central or State register of Indian Systems of Medicine shall be eligible for admission in the post-graduate degree course.
 - (b) must obtain the minimum eligibility marks in the AIAPGET or any other Post Graduate Entrance Test conducted by any competent authority as designated by Ministry of AYUSH, Government of India from time to time, for admission into the Post Graduate course except sponsored candidates.
- (ii) The minimum eligibility marks for admission into Post Graduate course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the AIAPGET held for the said academic year:

Provided that in respect of,

- (a) candidates belonging to the Scheduled Castes, Scheduled Tribes and OBC/MOBC, the minimum marks shall be at 40th percentile;
- (b) candidates with benchmark disabilities specified under rule 5(6) of this rule, the minimum marks shall be at 45th percentile for the General Category including EWS category and 40th percentile for the Scheduled Castes, Scheduled Tribes and OBC/MOBC.
- (iii) For State Quota Seats, the candidate must-
 - (a) be a citizen of India;
 - (b) be a permanent resident of Assam and must furnish a certificate to this effect.
- (iv) For NEC Quota Seats, the Secretary, North Eastern Council (N.E.C.) shall recommend the candidates through a certificate at Annexure-I in

Application Form at **Schedule-III** of these rules and it must be submitted along with the Application Form to be eligible for the N.E.C. Quota Seat.

(v) For Medical Officer(Ayurvedic) Quota Seats-

- (a) He/she must complete minimum five years of regular service on or before 31st July of that session as Medical Officer (Ayurvedic)under State Health Services, Assam.
- (b) The candidates applying for the Medical Officer Quota seats shall have to submit the duly filled up Application Form as appended in Schedule-III with recommendation of the appointing authority i.e, Secretary to the Government of Assam in Health & Family Welfare Department through a certificate at Annexure-II of the Application Form of these rules and it must be submitted in due course of time as per notification published by Director of AYUSH in this regard.
- (c) The doctors applying for seats under Medical Officer (Ayurvedic) quota shall execute a Registered Bond for Rs.20,00,000/-(Rupees Twenty lakhs) indicating that on completion of the post Graduate courses, he/ she shall be bound to serve the State Government for at least 10years.

(vi) For CGN Quota Seats-

- (a) The sponsored candidates recommended by the Ministry of AYUSH, Government of India for admission into Post Graduate Course shall not be subjected to entrance test i.e. AIAPGET.
- (b) The Private CGN candidates must qualify the AIAPGET. They have to apply to the Principal, Government Ayurvedic College, Guwahati, Assam, through their respective deficient State/UT with recommendation of the state /UT Government along with all necessary documents for their candidature for admission. While nominating/recommending their private CGN candidate for Post Graduation Course, the concerned State/UT Government will have to certify the deficiency of the concerned discipline (speciality) in their State/UT.
- 7. DISTRIBUTION OF SEATS AGAINST DIFFERENT QUOTA: The detail distribution of seats against different categories is shown in Schedule-II and its equal distribution against all Post Graduation subjects are done on rotation basis for successive academic sessions as shown in Schedule-IV of these rules and it may be continued for further successive sessions in same way by maintaining the rotation for distribution.

The seats allotted against different quotas are given below-

- (i) All India Quota Seats- Each academic session, 4(four) seats (15% of the total seats) as referred in clause(I) of rule 4 of these rules shall be reserved for the All India Quota. These 5(five) seats are distributed in alphabetic manner of the existing Post Graduation subjects with effect from the session 2019-20 as per direction of Ministry of AYUSH, Government of India vide letter no.R.11011/02/2018-EO(IM-1)(VOL-.2) dated 08.08.2019.
- (ii) N.E.C. Quota Seats- Each academic session, 2(two) seats (i.e. one in Ayurved Samhita & Siddhanta and another one in Kayachikitsa) shall be reserved for the Candidates for North Eastern States except Assam.
- (iii) CGN Quota Seats-Each academic session, 2 (two) seats (i.e. one in Ayurved Samhita & Siddhanta and another one in Kayachikitsa) shall be reserved for the candidates of Central Government Nominee.
- (iv) State Quota Seats- Each academic session, total 21 (twenty-one) seats shall be reserved for State Quota Candidates and their distribution against different reserved categories as specified under rule 5 of these rules shall be distributed in all Post Graduation subjects in rotation basis as shown in Schedule-IV of these rules.

8. COUNSELING PROCESS:

(i)

(1) Selection Board: There shall be a Selection Board for the purpose of selection of candidates through counseling for admission into the Post Graduate course consisting of the followings-

- (v) Deputy Director (Ayurveda), Office of the Member Directorate of AYUSH, Assam-
- (vi) Any other officer to be co-opted by Director of Member AYUSH, Assam, as and when required-

(2) Notification for inviting application and counseling:

Selection of candidates to fill up the seats shall be made by holding counseling on the date and place notified by the Director of AYUSH. In this regard, the Director of AYUSH shall publish an educational notice through local leading News Paper (one Assamese and one English) and website of Director of AYUSH for inviting application in prescribed Application Form appended at Schedule -III of these rules from the eligible candidates for counseling for admission into the Post Graduate course at Government Ayurvedic College, Guwahati. After scrutiny of the Application Forms and preparation of category wise merit list, the counseling for selection of the candidates shall be held in due course of time. The Director of AYUSH shall publish Educational Notice indicating the dates and place for counseling and important terms and conditions to be fulfilled by the candidates called for counseling.

(3) Scrutiny of Application Forms and preparation of merit list:

All the Application Forms including NEC quota and Private CGN quota submitted by the candidates shall be scrutinised by a scrutiny committee constituted by the Director of AYUSH and the scrutiny committee shall prepare the merit list of the eligible candidates category wise separately and also the scrutiny committee shall prepare the list of cancelled Application Form if any indicating the reason for cancellation. The scrutiny committee shall complete the whole process in stipulated time and submit the same to the Director of AYUSH.

(4) Counseling Fee:

A candidates shall be required to deposit an amount of Rs.500/- (Rupees five hundred) only or any amount as fixed by Director of AYUSH from time to time as counseling fee through Treasury Challan into the State Exchequer under the Head of Account —"2210 Medical and Public Health-02 Urban Health Services-200 other system of Medicine-2970 Director of AYUSH (H.Q Estt)- 000 Null- 04 Office Expenses-11 refreshment expenses" and submit a copy of deposit challan Original / Duplicate/ Triplicate at the time of counseling".

(5) Method of Selection:

- (a) The candidates shall be selected by Selection Board through counseling as per the admission rule.
- (b) Candidates whose names appear in the merit list shall be called in the counseling serially before the Selection Board in order of merit

- to produce original documents/testimonials for verification by the Selection Board.
- (c) The Board on being satisfied with documents and certificates so produced by the candidates shall seek their choice of subject.
- (d) A candidate shall be allotted a seat in the subject of his/her choice by the Selection Board in accordance with his/her position in the merit list.
- (e) A candidate belonging to SC/ST(P)/ST(H)/OBC/MOBC and EWS can opt for General open seats in any subject if such a seat is available according to their position in the merit list or they may opt for any reserved seat of their own category that is available.
- (f) The candidate shall be physically present in the counseling.
- (g) The candidates shall show the following original documents at the time of counseling-
 - (i) Admit Card of the AIAPGET.
 - (ii) Mark Sheet/Rank Letter of the AIAPGET.
 - (iii) HSLC Admit Card/HSLC Pass Certificate.
 - (iv) Mark Sheets of HSSLC (10+2) and all BAMS Examinations.
 - (v) Internship Completion Certificate.
 - (vi) Permanent Residency Certificate.
 - (vii) Cast Certificate.
 - (viii) EWS certificate.
 - (ix) Permanent Registration Certificate of State Council or Board or Central council of Indian Medicine.
- (6) In case of doubtful cases the Selection Board shall refer the cases to the competent authority or to the State Forensic Laboratory for proper authentication.
- (7) If a candidates is absent in the counseling the Selection Board shall not allow any seat to him/her.
- (8) The candidates shall sign on the acceptance slip stating the subject in the Post Graduate Course allotted to him expressing his acceptance or non-

acceptance of the same and deliver it to Member Secretary of the selection Board.

9. ADMISSION:

- (1) All the selected candidates shall have to take admission on the day of counseling by depositing the admission fees as mentioned in rule 10 of these rules.
- (2) At the time of admission each candidate has to deposit the following documents in original. The documents shall remain in the safe custody of the Principal, Government Ayurvedic College, Guwahati, till the completion of the course and shall be returned to the candidate at the completion of the course.
 - (a) HSLC (or equivalent stage) Admit Card and Pass Certificate.
 - (b) Mark sheets of HSSLC (10+2) and all BAMS Examinations.
 - (c) Internship Completion Certificate.
 - (d) Registration Certificate of State Council of Indian Medicine or Central Council of India Medicine.
 - (e) Permanent Residency Certificate (wherever applicable).
 - (f) Caste Certificate issued by the competent authority (wherever applicable).
- (3) If a candidate resigns from the Post Graduation course at any time and the resignation shall be accepted after fulfillment of the conditions of Rule 14 of these rules.
- (4) If the certificates are required by the candidate for appearing in an interview for employment, the same can be given to him/her on application with copy of the call letter of the interview for 7 (seven) days only. The original must be returned to the Principal on return from the interview.

10. ADMISSION FEES:

The Admission fees and mode of payment shall be uploaded in the website of Director of AYUSH before starting the admission process.

11. REFUND OF FEES:

90% of the fees already deposited at the time of admission shall be refunded to a candidate who wants to leave the college or surrender the seat before the last date of admission. No candidates require to take re-admission for transfer from one

specialty to another specialty in case of surrender his already allotted seat of the specialty and accepting another seat of the other specialty as per his/her choice as allotted by the Selection Board in the subsequent counseling. No refund of fees shall be allowed after the last date of admission.

12. FORFEITURE OF SEAT:

- (a) The seat allotted to any candidate who fails to get admitted within the stipulated time as per the rule 9(1) of these rules, shall automatically be forfeited.
- (b) If at any stage during and after the process of selection/admission it is found that a candidate furnished a false statement in the Application or if the Certificates, Mark sheets, Permanent Resident Certificate (PRC) and other documents furnished with the Application are found false or fabricated, the seat given to such candidate shall be forfeited forthwith without any refund of any fee etc. paid in this regard and criminal proceedings shall be drawn against such candidates. He/She must also deposit the amount as noted in rule 13 (a) and 13(b) of these rules.

13. RESIGNATION/SURRENDER OF A SEAT AFTER LAST DATE OF ADMISSION:

Any candidate who wants to resign/surrender his/her seat after the last date of admission as per the schedule fixed by the Ministry of AYUSH, Government of India/Central Council of Indian Medicine for that particular session, he/she shall

- (a) Return the amount of stipend if already drawn by him/her during course of study by way of Bank Draft in favour of "Director of AYUSH, Assam" payable at Guwahati.
- (b) has to pay a penalty of Rs. 2,50,000/- (Rupees two lakh fifty thousand) only by way of Bank Draft in favour of "Director of AYUSH, Assam" payable at Guwahati.
- (c) be eligible to get back the original certificate deposited with the Principal only on the fulfillment of the provision of sub-rule (a) and (b) above.

14. CHANGE OF POST GRADUATION SUBJECT AFTER CUTOFF DATE OF ADMISSION:

After cutoff date of admission, if any new vacancy arises, the change of subject shall be permissible as per CCIM norms or Ministry of AYUSH, Government of India (if any in this regard) from time to time as applicable. The changing of subject shall be allowed among the candidates admitted in that academic year and only after allotment by the Selection Board.

In this regard, the Principal of the College shall communicate with the Director of AYUSH immediately for necessary arrangement if such vacancy arises within the permissible period as per CCIM norms or Ministry of AYUSH, Government of India.

15. SUBSEQUENT COUNSELING FOR FILLING UP OF THE VACANT SEATS:

- (a) Subsequent counseling shall be held to fill up the seats if lying vacant after first counseling. In the subsequent counseling, all the candidates who have already been admitted shall also be called to attend the counseling and they will get the chance to change their subject or to get allotment of a new seat against vacancy (if the candidate desires) in order of merit.
- (b) The reverted back vacant seats against 15% of All India Quota shall be filled up by the eligible candidate from the open category of State Quota candidates in order of merit of AIAPGET through counseling process.
- (c) If any reserved quota/category seat cannot be filled up from the concerned reserved quota/ category candidate due to non availability of eligible candidate in that particular category, then the vacant seats shall be filled up by eligible candidate from the open category of State Quota candidates according to merit of AIAPGET through counseling process.

16. STIPEND:

- (a) The students undergoing Post Graduate Course except the sponsored candidate under Central Government Nominee Quota, the candidate of Medical Officer (Ayurveda) quota and others who have received salary from their respective appointment authorities shall be paid a stipend as may be fixed by the Government from time to time.
- (b) The stipend will be paid subject to availability of fund only.
- (c) Student receiving/stipend/scholarship from other source are not entitled for the stipend of the undergoing Post Graduate Course.

17. APPEAL:

- a) Candidate aggrieved by the decision of the Selection Board have the right to appeal to the selection board and also to the Government within 7(seven) days from his/her date of counseling. Such appeals are to be addressed to: The Chairman of the Selection Board and/or The Secretary to the Government of Assam, Health and Family Welfare Deptt. Dispur, Guwahati - 781006, Assam.
- b) The Chairman of the Selection Board or the Government shall dispose of all appeals before the last date of admission for that particular session as fixed by CCIM/ Ministry of AYUSH, Government of India.

18. AGREEMENT:

- (a) All candidates including NEC quota and Private CGN candidates selected for admission into Post Graduate course in the Government Ayurvedic College, Guwahati, Assam, shall enter into an agreement in a non judicial stamp paper of Rs.100/- (Rupees one hundred) only with the Government of Assam as in Schedule-V appended to these Rules for binding himself/ herself to serve under the Health & Family Welfare Department, Govt. of Assam or Society/Agency created for implementation of National Programmes of disease control or National Health Mission (NHM)/National AYUSH Mission(NAM), Assam for a period of 3(three) year and in breach thereof to pay a sum of not less than Rs.20,00,000/- (Rupees twenty lakhs) to the Government as compensation. The amount is payable by way of Bank Draft in favour of "Director of AYUSH, Assam" payable at Guwahati.
- (b) The Medical Officer (Ayurvedic) selected against the reserved quota of Medical Officer (Ayurvedic) for admission into PG courses as per rule 5(vii) of these rules shall be bound to serve the State Government after completion of the course for at least 10 (ten) years and in breach thereof shall be bound to pay a sum of Rs.20,00,000/- (Rupees twenty lakhs) to the Government of Assam as compensation. The amount is payable by way of Bank Draft in favour of "Director of AYUSH, Assam" payable at Guwahati.
- (c) The candidates admitted in the Post Graduate courses through All India quota shall also enter into the agreement as mentioned in Rule 18 (a) if they draw stipend from the Government of Assam during their study period. However, if they do not draw the stipend during the study period, they will be exempted from the agreement.

19. ANTI RAGGING MEASURES:

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08/05/2009 in civil appeal No.887/2009, all students/ parents will submit antiragging related affidavit to the institutions at the time of Admission. The sample of the affidavit shall be collected from the office of the Principal of the college.

20. INTERPRETATION OF ANY CLAUSE OF THESE RULES:

In case of any doubt regarding interpretation of any clause of these rules during the counseling period then the decision of the Selection Board regarding the interpretation of that particular clause shall be final.

21. POWER TO RELAX:

Where the Government is of the opinion that it is necessary or expedient to do so, it may by order, not inconsistent with the provisions of these rules and for reasons to be recorded in writing, relax any of the provisions of these rules.

AND WHEREAS in the interest of public service, the First Party has decided to give admission to the Second Party into the Postgraduate Course at Government Ayurvedic College, Guwahati in the State of Assam and shall bear the expenses of his/her education, other than the admission fees, hostel fees and other charges, in pursuing the said course.

NOW, THEREFORE THIS AGREEMENT WITNESSES THE FOLLOWING TERMS AND CONDITIONS:

1. That, after successful completion of his/her Postgraduate Course the Second Party shall serve the State Government for minimum period of 3(three) years in respect of upon offer of appointment within a period of one month of the declaration of result in

any Health Institute under the Department of Health & Family Welfare, Govt. of Assam, or any Allied sector including agencies/institutions under NHM/NAM, Assam and/or any other State/Central Government sponsored Scheme/s.

- 2. That, the First Party shall have the authority to utilize the service of the student i.e. the Second Party in any Hospital/Medical Institutions within the State of Assam where there is necessity of a Doctor in the interest of public service.
