## **NOTIFICATION**

The 28th October, 2021

**No.PMA(S) 09/2017463.-** In pursuance of the Cabinet decision taken in the meeting of the Council of Ministers held on 24-09-2021 in the Conference Room of State Guest House, Koinadhara, Khanapara and for effective administrative control and monitoring of 'Adarsha Vidyalayas' functioning as on date under Samagra Siksha, Assam, the Government of Assam after careful consideration of all aspects is pleased to notify constitution of 'Adarsha Vidyalaya Sangathan' Assam for operationalization and management of 'Adarsha Vidyalayas' and the said Sangathan, will act as an autonomous body under Secondary Education Department, Government of Assam.

The "Adarsha Vidyalaya Sangathan, Assam" will be a registered society and shall be registered under relevant provision of Society Registration Act 1860 and will be regulated by following the **Memorandum of Association (MoA) and the Rules** as annexed herewith as Annexure-I &II respectively.

Further, one 'Model School' shall be established in each Legislative Assembly Constituency.

Necessary Budget Provision will also be made in the State Budget to meet the recurring and non-recurring expenditures for operationalization of 46 'Adarsha Vidyalayas' (may be extended by Govt. of Assam, as a future policy decision) which includes payment of Salary & Honorarium for the officials of Adarsha Vidyalaya Sangathan, payment of salaries to the teaching & non-teaching staff of Adarsha Vidyalayas as per ROP except daily wage worker, introduction of Hostel facilities for teachers and non-teaching staff, Office expenses, other contingencies, maintenance grants and all essentials expenditures as may be required for smooth functioning of the Adarsha Vidyalayas and Adarsha Vidyalaya Sangathan, Assam.

Besides there will be continuation of service of teaching fraternity of Adarsha Vidyalayas till attaining the age of 60 years subject to satisfactory annual performance report, entitlement of Contributory Provident Fund(CPF) benefit for teaching staff as per norms, entitlement of casual leave(CL)/ earned leave(EL)/maternity leave(ML)/ Child Care Leave(CCL) and other holidays as entitled to regular Govt. employees under GoA and entitlement to avail Bank loan facilities with due approval of the Govt.

Further, the "Adarsha Vidyalaya Sangathan, Assam" is empowered to generate additional fund for the Sangathan, as Vidyalaya Vikas Nidhi (VVN), with due approval of Govt., which will be utilized for the Adarsha Vidyalaya Sangathan, Assam and the Schools under it, as per decision of the Executive Committee of the Sangathan.

This notification will come in to force immediately.
