## NOTIFICATION

The 11th January, 2023

No.E-250913/8.- Whereas the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017 extends to the whole of Assam as per provision under sub-section (2) of section 1 of the said Act and all the venture educational institutions of the State of Assam come under the purview of the said Act if institution is not excluded specifically; and

Whereas the venture educational institutions covered under sixth schedules areas in Hills districts may not be the venture educational institutions in the meaning of the sub-section(zd) of section 2 of the said Act unless such institutions are brought under purview of the Act by a separate notification to be published in the official gazette; and

Whereas neither any proposal for inclusion of these institutions established under sixth schedules areas in Hills districts are forthcoming nor any separate legislation have been enacted by the concerned authority to provide provincialisation benefits to the employees of those institutions; and

Whereas the venture educational institutions of sixth schedule areas in Hills district including all other districts in the State of Assam submitted their applications in proper format as prescribed by the Government along with other documents for consideration for provincialisation of services of employees of their institutions; and

Whereas on the recommendation of the District Scrutiny Committee followed by the approval of the State Level Committee constituted under section 13 of the said Act, the Government in the School Education Department have provincialised the services of employees of the venture educational institutions falling under sixth schedules areas in Hills district; and

Whereas the Government in the School Education Department is satisfied that the circumstances exist which render it necessary for it to bring the venture educational institutions of sixth schedules areas in Hills district under purview of the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017 for provincialisation of services of their employee.

Now, therefore, in exercise of powers conferred under sub-section (zd) of section 2 of the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017, the Governor of Assam is hereby pleased to bring the venture educational institutions of sixth schedules areas in Hills districts under purview of the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017.

Further, in respect of the venture educational institutions falling under sixth schedules areas in Hills district which have been provincialised under this Act, the Government of Assam is also pleased to grant ex-post fact facto approval to inclusion of the venture educational institutions falling under sixth schedules areas in Hills district which have already been considered for provincialisation under the said Act.
