GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR HEALTH & FAMILY WELFARE (A) DEPARTMENT

NOTIFICATION

The 20th November, 2021

No. HLA.767/2021/28.- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Health Service Rules, 1995, hereinafter referred to as the principal Rules, namely:-

Short title and commencement

- (1) These rules may be called the Assam Health Service (Amendment) Rules, 2021.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 5

- In the principal Rules, in rule 5, for clause (i), the following shall be substituted, namely:-
 - "5(i) In the cadre of Director of Health Services, Assam and Director of Health Services (Family Welfare), Assam, recruitment shall be made through a Selection Committee consisting of the following members, namely:-

| 1 | Chief Secretary | Chairman |

Amendment of the Schedule IV

 In the principal Rules, for the existing Schedule IV, the following shall be substituted, namely:-

" Schedule IV

Qualification and experience for Director of Health Services, Assam and Director of Health Services (Family Welfare):

- (i) MBBS degree holders having Post Graduate qualification shall be given preference, PG degree holders shall get priority over PG diploma holders.
- (ii) Having minimum 20 (twenty) years of continuous service experience in the State Health services.
- (iii) Five years of administrative experience in the rank of Sub-Divisional Medical Health Officer or above.
- (iv) Minimum age 59 years and maximum age 63 years as on 1st January of the year in which advertisement for filling up the post has been published.".
