NOTIFICATION

The 19th December, 2023

No.MER.354019/258.-In view of commencement of Mukhya Mantri Lok Sevak Arogya Yojana (MMLSAY)-Medical reimbursement of Government employees, Government pensioners and their dependents through an online IT portal, an Admissibility Board is hereby constituted which will be the final authority to approve/reject any medical reimbursement claim in MMLSAY.

The composition of the Admissibility Board will be as follows:

- 1. Chairman: Chief Executive Officer, Atal Amrit Abhiyan Society
- 2. Members:
 - a. One nominated Doctor from Health & Family Welfare Department not below the rank of Joint Director.
 - b. Two Medical Officers from the Government Medical Colleges preferably not below the rank of Assistant Professor of Medicine/ Surgery.
 - One nominated member from State Finance Department not below the rank of Financial Advisor.
 - d. Senior Medical Officer, Atal Amrit Abhiyan Society.
 - e. Senior Financial Advisor, MMLSAY.
 - f. Any other member nominated by Chief Executive Officer, Atal Amrit Abhiyan Society.

The Terms of Reference of the Board will be as follows:

- 1. The Admissibility Board will have at least one sitting every fortnight.
- All the medical reimbursement claims recommended by the Implementation Support Agency and scrutinized by the Project Management Unit of Atal Amrit Abhiyan Society will be taken up by the Admissibility Board for consideration of approval.
- 3. Reimbursement claims will be paid to the beneficiaries only after approval from the Admissibility Board.
- 4. The Admissibility Board will also be the sole authority for part reimbursement as per the criteria set out in the operational guidelines of MMLSAY.

- 5. The Admissibility Board may recommend any reimbursement claim/ claims for audit.
- 6. The Admissibility Board may recommend any reimbursement claim/ claims for investigation by law enforcement agency.
- 7. The Admissibility Board may recommend to Government for action against any employee/pensioners in the event of detection of fraud/ abuse of the scheme benefits.
- 8. The Admissibility Board will decide on any change in the basic criteria of treating hospitals.
- 9. The Admissibility Board will take steps to act in proven fraud/ malpractice in case of any treating hospital.
- 10. Claims can also be approved by the Chairman and the Senior Financial Advisor, MMLSAY in case the Admissibility Board does not have any sitting for any reason. However, such claims will be ratified by the Admissibility Board at a later date.
