## NOTIFICATION

The 11th October, 2022

**No. SEC.71/2022/24.-** Whereas, in pursuance of the notification of the Governor of Assam No. TAD/BC/157/2015/3 dated 18.04.2015 entrusting the Assam State Election Commission with the responsibility to act as the Authority to supervise, direct and conduct elections to constituencies of the General Council of the Deori Autonomous Council, the Commission appointed the DEO/RO/ARO/ERO/AERO in respect of 22 (twenty two) nos. of Constituencies of the Deori Autonomous Council for conduct of Election, vide Notification No. SEC.83/2020/110 dated 19.07.2022;

And, whereas, reservation of seats for women in the Deori Autonomous Council has been notified by Government of Assam vide No. TAD/615/2018/193 dated 25.07.2022;

And, whereas, the Assam State Election Commission notified the schedule for preparation and publication of constituency -wise photo electoral roll for Election to the Deori Autonomous Council vide Notification No. SEC.83/2020/121 dated 27.07.2022;

And, whereas, the final Photo Electoral Rolls in the 22 (twenty two) Constituencies under Districts of Tinsukia, Dibrugarh, Sivasagar, Jorhat, Majuli, Dhemaji, Lakhimpur and Biswanath have been published;

Now, therefore, in pursuance of Rule 17(1) and Rule 18 of the Deori Autonomous (Election) Rules 2009, the Assam State Election Commission hereby notifies to call upon each of the 22 (twenty two) nos. of Deori Autonomous Council constituencies as specified at **Schedule (A)**, to elect members to the Deori Autonomous Council in the state of Assam in accordance with the provisions of the Deori Autonomous Council Act, 2005 and the aforementioned Rules, 2009.

Further, the Commission hereby notifies the schedule (provided at **Schedule (B)**) for holding the Election to the Deori Autonomous Council from each of the 22 (twenty two) nos. of Deori Autonomous Council constituencies.

The Returning Officers already appointed for conduct of the said Election shall forthwith publish Public Notice of the Election in accordance with Rule 19 of the Deori Autonomous Council (Election) Rules, 2009 (on the same day of this Notification).
