## NOTIFICATION

The 14th September, 2022

No. PHED.296/2022/25.-In view of the decision of the Council of Ministers in its Meeting held on 06/09/2022, the Governor of Assam is pleased to amend the following provisions of revision of implementation framework of the State under JJM, PHED, Assam in supersession of all earlier amendments in this regards.

For empowering the existing hierarchy of the Department and restoration of the Delegation of Financial Powers as per the directions of the Cabinet, a restructured guideline in the implementation framework has been made and tabulated below.

### A. ADMINISTRATIVE APPROVAL OF SCHEMES

1	Chairman DWSM	Upto Rs. 10 cr.	Unchanged
2	Mission Director JJM	Upto Rs. 20 cr.	Unchanged
3	Senior Most Secretary of PHE	Unlimited Power	Unchanged

**B. TECHNICAL SANCTION OF SCHEMES**

Sl. No.	Designation	Extent of Power	Remarks
1	Executive Engineer	Individual Scheme value upto Rs. 1.5 cr.	Changed from upto 2 cr. to 1.5 cr.
2	Superintending Engineer	Individual Scheme value more than Rs.1.5 cr. upto Rs 5 cr.	Changed from more than 2 cr. to more than 1.5 cr.
3	Additional Chief Engineer	Individual Scheme values more than Rs. 5 cr. upto Rs 7 cr.	Unchanged
4	Chief Engineer	Full Power	Unchanged

**C. WORK ALLOTMENT**

Sl. No.	Designation	Extent of Power
1	Executive Engineer	Schemes be awarded individually or in packages. If awarded in packages, the size of such package should not exceed Rs.1.5 cr.
2	Superintending Engineer.	Schemes may be awarded in packages, the size of such package should not exceed Rs.5 cr.
3	Additional Chief Engineer.	Schemes may be awarded in packages and the size of such package should not exceed Rs.7 cr.
4	Chief Engineer	Schemes may be awarded in packages which are more than Rs.7 Cr with the approval of the Hon'ble Minister, PHED.

Based on the geography of the works, past history of the works executed, the new works will be grouped into packages of schemes at the Mission Directorate level based on the inputs / proposals from the field offices with the approval of the Government on the basis of which work will be allotted as per revised DFP.

As the award of works are predominantly in the nature of a Rate Contract which was derived on the basis of lowest item wise rates through RFP, the Divisions, Circles, Zones and the Mission Directorate will award works among the eligible empanelled contractors on the basis of their past performance in JJM indicated by the Scoring Matrix (for the existing contractors) and their prior experience in other sectors (for new contractors) with the approval of the Government.

The proposed new guideline with regards to the Delegation of Financial Powers described above shall uniformly apply to all areas, including the Sixth Schedule Areas.

**Role of 6<sup>th</sup> Schedule Councils in respect of 6<sup>th</sup> Schedule Areas.**

The role of 6<sup>th</sup> Schedule Councils in respect of 6<sup>th</sup> Schedule Areas will be same as mentioned above. The Delegation of Financial Powers described above will be uniformly applied to the Sixth Schedule Areas. In case of A.A. of schemes, the respective Deputy Commissioner shall accord A.A. as described in point '*A*' *Administrative Approval of Scheme* at page No.1, on behalf of the Principal Secretary cum Chairman, DWSM.

The implementation of the work will be done under the oversight of Deputy Commissioners and the work allotment upto Rs.7 Crores will be made as described in point '*C*' *Work Allotment* at page No.2 with the approval of the Principal Secretary, as per packages approved by the Government.
