## NOTIFICATION

The 15th October, 2022

No. HMA-19015/9/2019-Political(A)/Pt.(I)/20.- Whereas, the Government of Assam in exercise of powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 (Act 28 of 1958) had declared the areas covering 9 (Nine) districts and 1 (One) Sub-division viz. (1) Tinsukia (2) Dibrugarh (3) Charaideo (4) Sivasagar (5) Jorhat (6) Golaghat (7) Karbi Anglong (8) West Karbi Anglong (9) Dima Hasao and (10) Lakhipur Sub Division of Cachar district of the State of Assam as "Disturbed Area" vide notification No.HMA-19015/9/2019-POLITICAL(A)/120, dated 31/03/2022 with effect from 01/04/2022 for a further period of 6 (six) months;

Whereas, a review of the law and order and security scenario in Assam in the recent past indicates that the situation has considerably improved in West Karbi Anglong district of the State;

Now, therefore, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No.HMA-19015/9/2019-POLITICAL(A)/120, dated 31/03/2022, the Governor of Assam is pleased to **withdraw** the declaration of "Disturbed Area" w.e.f. 01.10.2022 from West Karbi Anglong district of Assam.

Further, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 and in supersession of earlier Notification vide No.HMA-19015/9/2019-POLITICAL(A)/120, dated 31/03/2022, the Governor of Assam is pleased to declare the areas covering **8 (Eight) districts and 1 (One) Sub-division viz. (1) Tinsukia (2) Dibrugarh (3) Charaideo (4) Sivasagar (5) Jorhat (6) Golaghat (7) Karbi Anglong (8) Dima Hasao and (9) Lakhipur Sub Division of Cachar district of the State of Assam as "Disturbed Area" for a further period of 6 (six) months w.e.f. 01/10/2022, unless withdrawn earlier.**
