GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR TOURISM DEPARTMENT

NOTIFICATION

The 6th December, 2003

No. TSM.93/99/51.- In excercise of powers conferred by the proviso of Articles 309 of the constitution of India, the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Tourism Service Rules, 1995, hereinafter referred to as the principal rules, namely:-

Short title and commencement

- 1. (1) These rules may be called the Assam Tourism Service (Amendment) Rules, 2003.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 7

- 2. In the Principal Rules, in rule 7, in clause (a)—
 - (i) For sub-clause (iii), the following shall be substituted, namely:-
 - "(iii) Joint Secy./Deputy Secy.-Member-Secretary"
 - (ii) after sub-clause (iii) so amended, the following new clause shall be inserted, namely:- "(iv) Director of Tourism-Member."

Amendment of rule 9

- 3. In the Principal Rules, in rule 9,-
 - (i) in sub-rule (1), in clause (c), after the existing provisions, the following shall be inserted, namely:-

"The number of candidates in such a list, may be as far as practible equal to double the number of actual vacancies." : (ii) in sub-rule (2) for clouse (c) the following shall be substituted, namely:—

"(c) The Committee shall make the selection in accordance with such procedure as prescribed by the Government. The Committees shall make selection of the posts on the results of the writter examination to be conducted by the committee in the manner laid down in Schedule-III to these Rules.

Candidates shall be called for an interview in order of merit in the written examination. The list of suitable candidates prepared by the Committee shall be forwarded to the Appointing Authority.

The number of candidates in the list may be double the number of actual vacancies."

Amendment of rule 11

4. In the Principal Rules, in Rule 11, Sub-rule (3) shall be omitted.

Substitution of Schedule-II

5. In the Principal Rules, for the existing provisions of Schedule II, the following shall be substituted, namely:-

"Schedule-II (See Rule 10)

Minimum Qualification for direct recruitment for the post of Tourist Information Officer and Asstt. Tourist Information Officer shall be a Bachelor Degree in Arts, Science or Commerce from a University recognized by the Government or a two years post Graduate Degree or a Diploma in Tourism and Travel Management or a three years Diploma in Hotel Management and Catering Technology from an institute recognized/approved by Govt. of India/Govt. of Assam.

The candidate should be capable of expressing himself in English properly and fluently as he will have to deal with foreigners and Tourists from other States of India. Candidates with degree/certificate in foreign language will get preference."

Insertion of Schedule-III

6. In the principal Rules, after the existing schedule II, the following shall be inserted as Schedule-III namely:-

"Schedule-III (See Rule 9)

The examination shall be conducted by the Committee constituted under Rule 7(b) in accordance with the syllabus as set forth below:-

General English : 100 Marks
 General Knowledge : 100 Marks
 Arithmatic : 100 Marks
