NOTIFICATION

The 15th November, 2022

No. ASE. 456/2022/43.- In exercise of powers conferred under sub-section (3) and (4) of section 8 of the Assam Education (Provincialisation of Services of Teachers and Re-organisation of Educational Institutions) Act, 2017, the Governor of Assam is hereby pleased to notify the following scope of works, terms and conditions of services in respect of the Tutors whose services have been provincialised under this Act, namely:-

- 1. The post of a Tutor shall be a separate cadre. It shall not be with the cadre of Teachers. As and when a Tutor whose services have been provincialised under section 4 of the aforesaid Act, acquires the requisite qualification, the post shall be upgraded to the post of Teacher and shall be en cadre in respective cadre of the teacher.
- 2. The Tutor shall continue to perform the duties as per the earlier responsibilities prior to provincialisation. To illustrate, if the services of a Science Graduate Teacher is provincialised as Tutor, he/she shall have to teach science subject as was done earlier in the school prior to provincialisation of his/her services.
- 3. A Tutor shall be assigned duties at par with other Teachers as was assigned prior to provincialisation without any disparity with other Teacher. The Tutor may be engaged for Examination duties and other duties as any other Teacher is expected to perform or assigned by the Authorities.

- 4. The Tutors may be upgraded to the Teacher on fulfillment of condition as prescribed in the Act.
- 5. The Tutor shall be allowed fixed pay as prescribed in the Act. In the event of his/her upgradation to the post of Teacher as per the provision in the Act, the Tutor hence upgraded as Teacher may enjoy the time scale of pay after his up-gradation to the post of Teacher.
- 6. The period of service as Tutor shall not be counted for any purpose.
- 7. The Tutor shall be entitled to Casual Leave, Maternity Leave, Child Care Leave as admissible to other regular Teachers and Study Leave without Pay or any other leave as may be specifically notified by the Government.
- 8. The superannuation age of the Tutors shall be at par with that of other Teachers.
- 9. The Head of the Institution shall furnish Performance report in respect of the Tutors individually at the end of each year to the concerned Inspector of Schools or District Elementary Education Officer as the case may be. In the event, if a Tutor happens to be the Head of the Institution, the Inspector of Schoolsor District Elementary Education Officer as the case may be, shall record performance report annually in respect of such Tutors.
- 10. The Inspector of Schools or District Elementary Education Officer as the case may be, shall issue order of biennial increase of pay of the Tutors on the basis of the satisfactory performance report as provided in the Act.

Further, consequent upon merger of two Departments viz Secondary Education and Elementary Education Department in a new Department namely Department of School Education, this shall be applicable to the Tutors of the secondary and elementary level schools under Department of school Education.

This is issued in supersession of the Notification issued vide No PMA 375/2017/95 Dated 5thMarch, 2021.
