PRELIMINARY NOTIFICATION

The 19th November, 2022

No. LA.2/2017/250.- That vide notification No.RLA.300/2013/Pt/160 dtd. 7th April, 2022, the District Collectors have been appointed as 'Appropriate Government' in relation to acquisition of any extent of land for a public purpose within their respective jurisdiction. And, whereas it appears to the appropriate government that a total of 261 Bigha 4 Katha 5 Lessa (86.56 Acres) of land is required in village Dhangiri, Mouza Panbari, Sonapur Revenue Circle, District Kamrup Metropolitan for public purpose, namely for Air Force station, Digaru, Assam. That vide order of LA.2/2017 dtd.11.11.2022 it is established that Social Impact Assessment and Rehabilitation & Resettlement will not be applicable in this case as Air Force Station, Digaru has been under active possession in the proposed land to be acquired since 1962-63. It is not a fresh land acquisition.

This notification is hereby made under the provision of Section 11(1) of the Right to Fair compensation & Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act No. 30/2013), to all whom it may concern.

A plan of the land may be inspected in the office of the Collector and office of the Circle Officer, Sonapur on any working day during the working hours.

I am pleased to authorize Circle Officer, Sonapur and his staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for proper execution of their work as provided and specified in section 12 of the Act. It is to be mentioned here that the requiring department has certified in Form-I (sub-rule (1) of rule 3) that the land to be acquired was demarcated on the field.

Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase, etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person interested within 60 (sixty) days from the date of publication of this notification as provided under section 15 of the Act before Collector.
