## NOTIFICATION

The 30th December, 2022

**No. ecf-E-262925/3.**- Subsequent to the previous Notification No.GLR(RC)96/2009/207, dated 25-04-2022, the rates of VDA payable to the Domestic workers are fixed on the basis of 100% rise on average all India Consumer Price Index for Industrial Workers (Base year 2016=100).

And whereas the All India CPI (IW) average of the period December, 2021 to May, 2022 has risen by 2.8 points (i.e., 2.26 %) over the average CPI of the period June, 2021 to November, 2021.

Now, it is hereby notified that the following VDA shall be payable to the **Domestic Workers** as specified in Schedule given below **w.e.f. 01-06-2022**.
