NOTIFICATION

The 18th February, 2019

No. FSC.30/2018/218.- Upon receipt of report from the Food Analyst to the Govt. of Assam and upon consideration of the same, it reveals that the sample of Aquos Packaged Drinking Water is unsafe in terms of the provisions of Section 3(1) (zz) of the Food Safety and Standards Act, 2006.

Whereas, the sample of Aquos Packaged Drinking Water does not conform to the prescribed standards as laid down in Regulation 2.10.8 of Food Safety and Standards (Food Products Standards and Additives) Regulations, 2011 and declared un-safe according to Section 3(1) (zz) of Food Safety and Standards Act, 2006 by the Food Analyst to the Govt. of Assam vide Report No. FSS/G/123/18 dtd. 29/08/2018 thereof.

Therefore, in exercise of power conferred under Section 30(2) (a) of Food Safety and Standards Act, 2006, the undersigned hereby in the interest of public health prohibit the manufacture, storage, distribution and sale of Aquos Packaged Drinking Water manufactured by M/s. Hydro Craft Industries, Bamunimaidam, Industrial Area, Guwahati-21, Kamrup Metropolitan District, Assam in the State of Assam with immediate effect for a period of 15 (fifteen) days.

Nothing in this order shall bar the manufacturer from producing Aquos Packaged Drinking Water for the purpose of testing and analysis towards improvement during the period of prohibition, in the presence of the Food Safety Officer.

The Designated Officers, Food Safety of the districts are hereby directed to strictly enforce this prohibition Notification and furnish the reports thereof accordingly without fail.

The Designated Officer, Food Safety, Kamrup Metropolitan District is also hereby directed to serve improvement notice under Section 32 of Food Safety and Standards Act, 2006 to secure compliance with the improvement notice within the specified period.
