Whereas, the Election Commission of India is satisfied that of the contesting candidate specified in column 4 of the Table below at the General Election to the House of the People, 2019, in the State of Assam held from the constituency specified in column 3 against his name, has failed to lodge the account of his election expenses as required by the Representation of the People Act, 1951 and the Rules made thereunder;

ORDER

And whereas, the said candidate has not furnished any reason or explanation for the said failure even after due notice by the Election Commission and the Election Commission is satisfied that he has no good reason or justification for the said failure;

Now, therefore, in pursuance of section 10A of the said Act, the Election Commission hereby declares the person specified in column 4 of the Table below to be disqualified for being chosen as and for being a member of either House of Parliament or the Legislative Assembly or Legislative Council of a State or Union Territory for a period of three years from the date of this order:
