## NOTIFICATION

**No.HMA.19028/02/2017-Pol.(A)/(Ecf-7836)/69.-** Whereas having regard to the circumstances prevailing in and likely to prevail in the districts of (1) Cachar (2) Karimganj (3) Hailakandi (4) Dima Hasao (erstwhile N.C. Hills) (5) Karbi Anglong (6) Dibrugarh (7) Tinsukia (8) Sivasagar (9) Jorhat (10) Golaghat (11) Dhemaji (12) Lakhimpur (13) Sonitpur (14) Darrang (15) Kamrup (M) (16) Kamrup (17) Nalbari (18) Barpeta (19) Bongaigaon (20) Goalpara (21) Dhubri (22) Kokrajhar (23) Chirang (24) Baksa (25) Udalguri (26) Nagaon (27) Morigaon (28) Charaideo (29) West Karbi Anglong (30) South Salmara (31) Majuli (32) Bajali (33) Biswanath (34) Tamulpur (35) Hojai, the Governor of Assam being satisfied that it is necessary to do so, hereby directs that the District Magistrates of all the above districts and Commissioner of Police, Guwahati, if also satisfied, as provided in Sub-Section (2) and (3) of Section 3 of the National Security Act (NSA), 1980, exercise the powers conferred by the said sub-section in any area within their respective local jurisdiction, beyond 30<sup>th</sup> November, 2023.

Now, therefore, in exercise of the of the powers conferred by the proviso to Sub-Section (3) of Section 3 of the National Security Act (NSA), 1980, the Governor of Assam is hereby pleased to accord ex-post facto approval towards extension of the period of validity of the Government Notification No.HMA. 19028/02/2017-Pol-A(Ecf7836)/68 Dated 31.07.2023 for a further period of 3 (three) months with effect from 01/12/2023.
