It appears from the letter dated 1st July, 2022 from MD, AFDC Ltd that the Director, ICAR - CIFRI, Kolkota has proposed to set up Research and Development Activities in Assam for the benefits of Fishermen to demonstrate various aspect of Beel management and other emerging issues for sustainable utilization Beel Fisheries in the State for which it has identified a plot of land measuring 2 Ha in the periphery of Ghorajan Beel which is under AFDC Ltd. located at Amingaon in North Guwahati in Kamrup District.

Preliminary discussion has already been held between ICAR- CIFRI & AFDC Ltd. in 2020. AFDC Ltd. is agreeable to provide the said plot of land to CIFRI in the interest of Beel Development in the State since such research and other activities will immensely benefit the Fishery sector in the State.

In view of above, competent authority of Govt. of Assam, Fishery Department on behalf of Governor of Assam is pleased to accord approval / No objection for handing over the plot of land measuring 2ha on 99 years lease in the periphery of / under Ghorajan Beel on following terms and conditions:

- i) A MOU will be signed between ICAR -CIFRI and AFDC Ltd. incorporating all relevant legal/administrative issues and Draft MOU to be vetted by Competent Authority of Parent Department subject to ratification of Govt. decision by the Board of Directors of the Corporation in due course.
- ii) The said plot of land will be given to ICAR- CIFRI on 99 years lease at a nominal value of one time payment of Rs 99,000.00 as agreed upon.
- iii) The leased land shall be utilized for the purpose for which it has been allotted within a period of 3 years by ICAR -CIFRI.
- iv) The rights of fishing over Ghorajan Beel by the legally engaged lessee of AFDC Ltd. shall not be adversely affected by the activities of ICAR-CIFRI from the facilities to be set up in the periphery of the fishery.
- v) The land will be identified and demarcated through Circle Officer, Amingaon assisted by LR Staff and Trace Map prepared by LR Staff and land to be handed over to authorized representative of ICAR-CIFRI by MD, AFDC Ltd. in presence of Circle Officer Amingaon, officials of Fishery Department represented by District Fishery Development Officer, Kamrup & lessee of Ghorajan Beel.
